



In Defense of Free Speech in Universities

A Study of Three Jurisdictions Amy Lai

In this book, Amy Lai examines the current free speech crisis in Western universities. She studies the origin, history, and importance of freedom of speech in the university setting, and addresses the relevance and pitfalls of political correctness and microaggressions on campuses, where laws on harassment, discrimination, and hate speech are already in place, along with other concepts that have gained currency in the free speech debate, including deplatforming, trigger warning, and safe space. Looking at numerous free speech disputes in the United Kingdom, the United States, and Canada, the book argues for the equal application of the free speech principle to all expressions to facilitate respectful debates. All in all, it affirms that the right to free expression is a natural right essential to the pursuit of truth, democratic governance, and self-development, and this right is nowhere more important than in the university.





Climate Games

Experiments on How People Prevent Disaster Talbot M. Andrews, Andrew W. Delton, and Reuben Kline

Can humanity work together to mitigate the effects of climate change? *Climate Games* argues we can. This book brings together a decade and a half of experimentation, conducted by researchers around the world, which shows that people can and will work together to prevent disasters like climate change. These experiments, called economic games, put money on the line to create laboratory disasters. Participants must work together by spending a bit of money now to prevent themselves from losing even more money in the future. Will people sacrifice their own money to prevent disaster? Can people make wise decisions? And can people decide wisely on behalf of others? The answer is a resounding yes.

Technical Territories

Data, Subjects, and Spaces in Infrastructural Asia Luke Munn

Infrastructures have now become geopolitical, strategic investments that advance national visions, extend influence, and trigger trade wars. Yet at the same time, these technologies also challenge sovereignty as a bounded container, enacting a more distributed and decoupled form of governance. Such "technical territories" construct new zones where subjects are assembled, rights are undermined, labor is coordinated, and capital is extracted. The stable line of the border is replaced by more fluid configurations of power. Luke Munn stages an interdisciplinary intervention over six chapters, drawing upon a wide range of literature from technical documents and activist accounts, and bringing insights from media studies, migration studies, political theory, and cultural and social studies to bear on these new sociotechnical conditions.




Generational Politics in the United States

This book is the first comprehensive book that examines the concept of generations from a political science perspective. It defines what a generation is and how to sort out the differences between life cycle, cohort, and aging effect. The book then brings together chapters from an array of political science scholars that examine the role of generations in American politics and how it relates to other variables such as age, race, gender, and socioeconomic status. It discusses how politics in the United States are impacted by changes in generations, including how the passing of the Baby Boom generation and rise of the Millennials and Gen Z will change American politics. By examining the differences in political attitudes, engagement, and impact of recent generations, *Generational Politics in the United States* suggests how generational change will impact American politics in the future.



The Medieval Constitution of Liberty

Political Foundations of Liberalism in the West Alexander William Salter and Andrew T. Young

This book discusses the constitutional order that characterized the High Middle Ages. The authors provide a historical account of how this constitutional order evolved following the fall of the Western Roman Empire. This account runs from the settlements of militarized Germanic elites within the imperial frontiers, to the host of successor kingdoms in the sixth and seventh centuries, and through the short-lived Carolingian empire of the late eighth and ninth centuries and the so-called "feudal anarchy" that followed its demise. Given this unique historical backdrop, Salter and Young consider the resulting structures of political property rights. They argue that the historical reality approximated a constitutional ideal type, which they term polycentric sovereignty. Salter and Young provide a theoretical analysis of polycentric sovereignty, arguing that bargains between political property rights holders within that sort of constitutional order will lead to improvements in governance.

International Organizations and Research Methods

An Introduction

Fanny Badache, Leah R. Kimber and Lucile Maertens, Editors

Scholars have studied international organizations (IOs) in many disciplines, thus generating important theoretical developments. Yet a proper assessment and a broad discussion of the methods used to research these organizations are lacking. This book compiles an inventory of the methods developed in the study of IOs under the five headings of Observing, Interviewing, Documenting, Measuring, and Combining. It does not reconcile diverging views on the purpose and meaning of IO scholarship, but creates a space for scholars and students embedded in different academic traditions to reflect on methodological choices and the way they impact knowledge production on IOs.

Kimber is a Post-Doctoral Fellow at Columbia University and Research Associate at the University of Geneva. Lucile Maertens is Senior Lecturer in International Relations at the University of Lausanne.

Administering Justice

Placing the Chief Justice in American State Politics Richard L. Vining Jr. and Teena Wilhelm

Administering Justice examines the leadership role of chief iustices in the American states, including how those duties require chief justices to be part of the broader state political environment. Vining and Wilhelm focus extensively on the power of chief justices as public spokespersons, legislative liaisons, and reform leaders. In contrast to much existing research on chief justices in the states, this study weighs their extrajudicial responsibilities rather than intracourt leadership. By assessing the content of State of the Judiciary remarks delivered over a period of sixty years, the authors are able to analyze the reform agendas advanced by chief justices and determine what factors influence the likelihood of success. These analyses confirm that chief justices engage with state politics in meaningful ways and that reactions to their proposals are influenced by ideological congruence with other political elites and the scope of their requests.

In recent decades violent ethnic conflicts have occurred in far greater frequency than state-to-state violence. The impact of protracted ethnic conflicts is often long-lasting and devastating to many sectors of society. For all ethnic conflicts, at least one of the conflict parties is fighting to protect their affiliated identity group; in many cases the combatants are engaged in a 'do-or-die' struggle for survival. Yet, many other ethnic conflicts are slow-burning affairs without the wide-spread occurrence of physical violence, but with the potential for violence that could erupt under certain conditions. Moreover, for most ethnic conflicts, sense of ethnicity, broadly defined, is
